**MINUTES**

- I. Call to Order.** Town Chair Aaron Anger called the meeting to order at 6:30 p.m. at the Mosel Town Hall, W982 County Road FF, Sheboygan. Also present were Supervisor Anne Woepse, Supervisor Dave Wagner, Constable Mike Langland and Clerk-Treasurer Sue Born. - II. Pledge of Allegiance.** All present stood and recited the Pledge of Allegiance.
- III. Introduction of Town Officers.** Chair Anger introduced the current Town officers to those in attendance.
- IV. Minutes of the April 17, 2018 Annual Town Meeting were handed out along with November 21, 2018 Public Hearing on the 2019 Budget and Special Town Meeting minutes for approval.** After review, Motion Mike Langland/Jay Christopher moved to approve the November 21, 2018 Public Hearing on the 2019 Budget and Special Town Meeting minutes; Carried 37-0.
- V. 2018 Year Recap, Anne Woepse.**
- Town Mosel had just under \$100,000.00 surplus in 2018 due to low snow amounts in 2018.
  - The building was going to be removed from the Immanuel Cemetery on County DL but was moved to 2019 due to lack of contractor response.
  - Ryder Cup meetings have started.
  - Adjustments were made at the Transfer Station capacity by adding an extra dumpster.
  - Agriculture Enterprise Zoning District was completed.
  - Farmland Preservation update was completed.
  - Town Mosel's Comprehensive Land Use Plan was renewed.
    1. Survey was sent out with 23% returned. Most responses were on roads, lake access, refuse in yards and transfer station hours.
  - Rowe Road lake access in process, may take a year or two. The Town is applying for a grant.

- VI. **Haven Fire Department Report.** Fire Department President Todd Grunwald reported the current officers are President Todd Grunwald, Vice President David Govek, Secretary-Treasurer Carl Demmin, Director Mike Gabsch, Director Jim Risseeuw and Fire Chief Thad Athorp. The Fire Department has 24 active fire fighters. The Department has 1 new Fire fighter who have accumulated 1000 training hours. The Fire Department had 61 emergency calls; 12 vehicle crashes, 8 car fires, 22 mutual aid structure fires, 5 grass fires and 14 others. 2018 purchases, on-going replacement of the protective gear. Capital Improvement Planning: Continue to meet with the Mosel Town Board for long and short-term planning; Replacement of Tender; Concrete upgrade/replacement; Building proposal.
  
- VII. **Haven Fire Department Building Project.** Fire Department President Todd Grunwald presented the Plans for the proposed additional building for the Fire Department. Grunwald answered questions from the audience.
  
- VIII. **Elector Vote. Vote to Authorize the Town Board to Purchase, Lease or Build a Building for the Town Use per Sec. 60.10 (2) (f).** Motion Brian Wunsch/Terry Johnson to authorize the town to purchase, lease or build a building for the town use. Motion Carried 36-1.
  
- IX. **Presentation and Discussion on Road Plan.** Chair Anger reviewed a power point presentation on the Town of Mosel Road Plan 2019 and Beyond. Anger answered questions from town residents. He also stated this is just a plan, some roads may be moved up to be worked on sooner if there is a need.
  
- X. **Transact any business over which the Annual Town Meeting has authority per Sec. 60.11(6), Wis. Stats.** Members of the Board may engage in discussion and information sharing in their capacity as Town Board members, but a Town Board meeting will not be held and no action will be taken.
  - A. **Questions/Comments/Actions from the Floor.** (Any topic/comment may be discussed, however, only those things over which the Town annual meeting has authority per Sec. 60.10, Wis. Stats., may be acted on.)
  
- XI. **Set Date for 2019 Annual Town Meeting** (Statutory Date is Tuesday, April 21, 2020. Motion Mike Gabsch/Mike Langland to hold the 2020 Annual Meeting on the statutory date of April 21, 2020; Carried 37-0.
  
- XII. **Adjourn.** Motion /Mike Scharl/Mike Langland to adjourn; Carried 37-0. Meeting adjourned at 8:00 p.m.
